

Settlement Engagement and Transition Support (SETS) program eligibility

TARGET GROUP

To ensure that SETS-Client Services funding is directed to those most in need, services are limited to those permanent residents who have arrived in Australia in the last five years as:

- humanitarian entrants
- family stream migrants with low English proficiency
- dependants of skilled migrants in rural and regional areas with low English proficiency
- selected other stream visas (Former Resident and Referred Stay (Permanent))

Also included in the SETS-Client Services target group are:

- selected temporary residents (Prospective Marriage, Provisional Partner visa holders and their dependants) in rural and regional areas who have arrived in the last five years and who have low English proficiency
- dependants of selected temporary residents (Provisional Skilled, Provisional Business or Investment) in rural and regional areas who have arrived in the last five years and who have low English proficiency

In addition, for SETS – Community Capacity Building, newly arrived communities which require assistance to develop their capacity to organise, plan and advocate for services to meet their own needs and which are still receiving significant numbers of new arrivals, are eligible.
